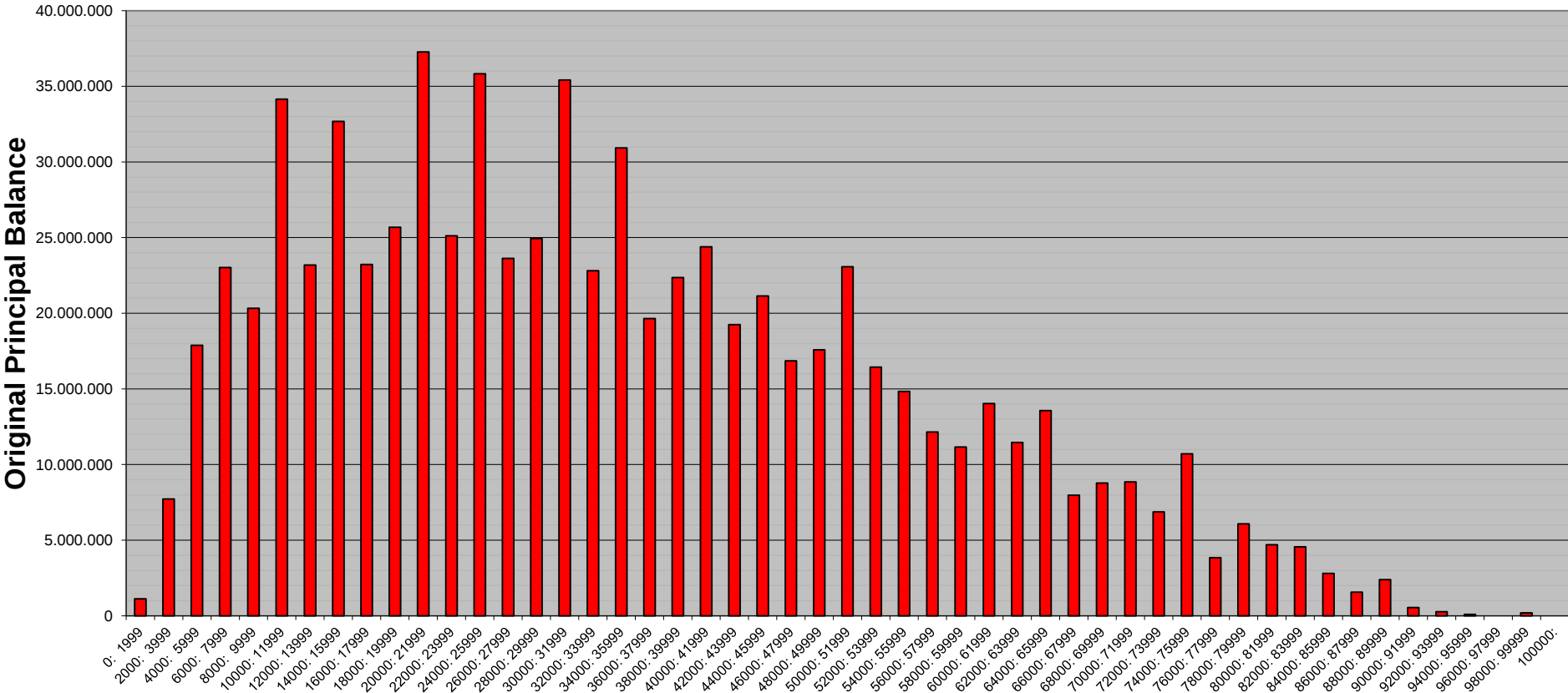

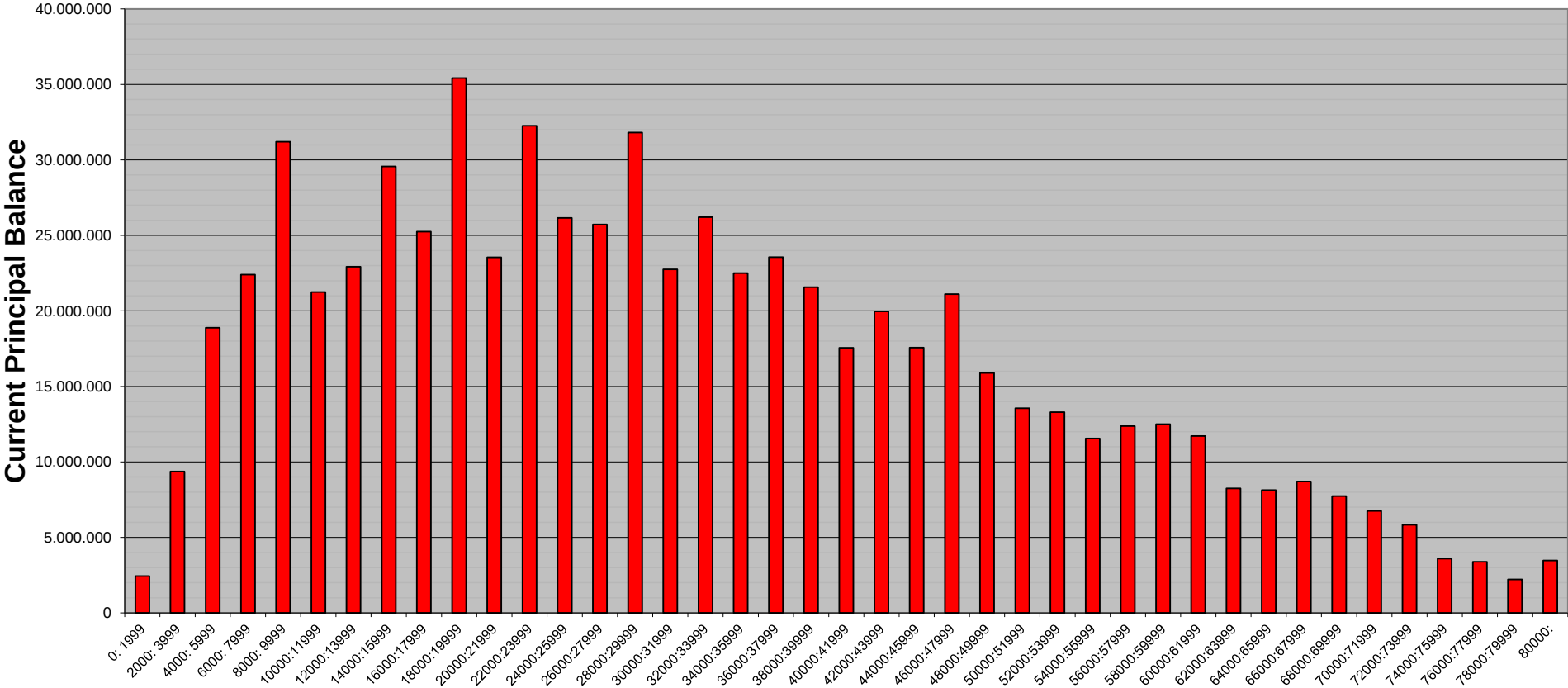

9. Geographical Distribution



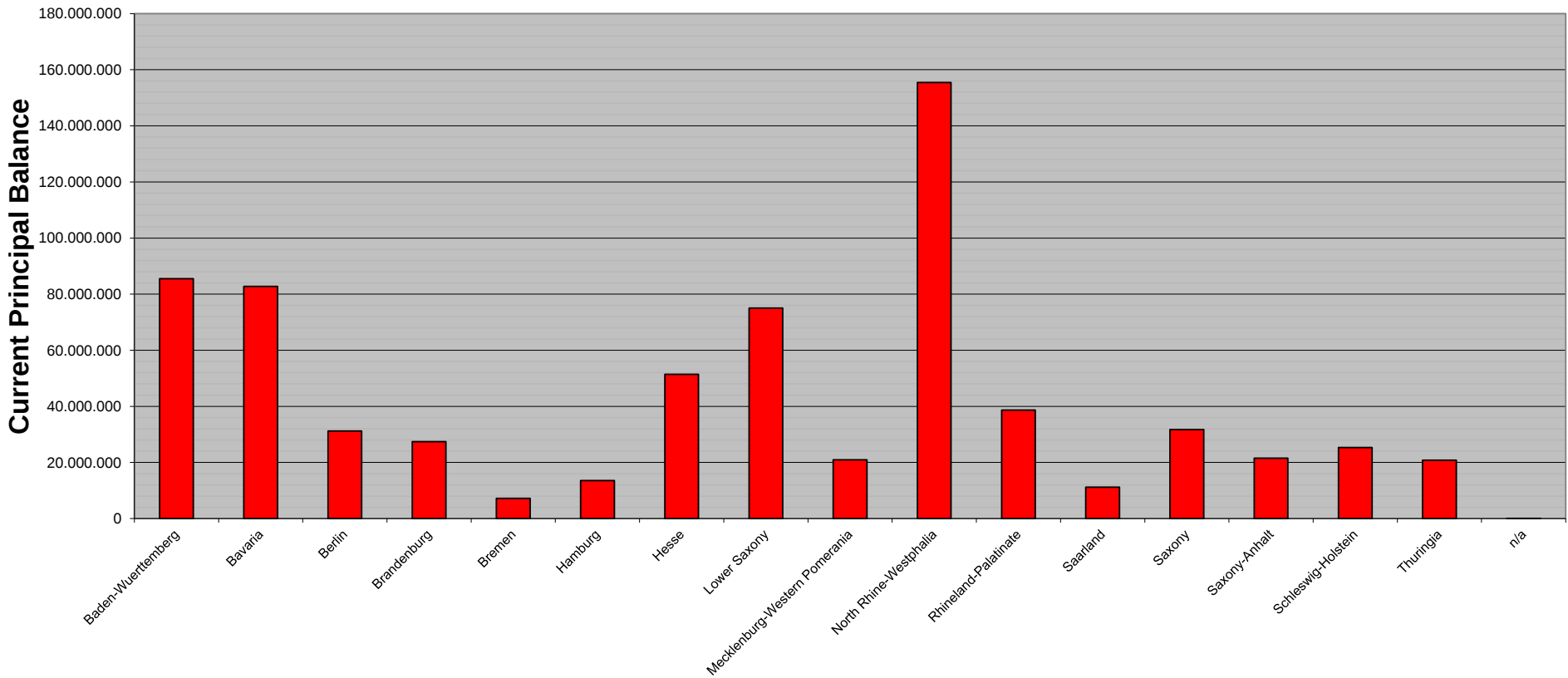
